Rector's Decree No. 79/2025 on the Fees and Tuition Fees for the Academic Year 2026/2027 - study programmes realised in English

European Research University

Part One Introductory Provisions

Article 1

This decree regulates the amount of fees associated with studies in study programmes realised in English at the European Research University, z.ú., in accordance with Part Eleven, Article 18 of the Statute of the European Research University, and in accordance with the Fees and Tuition Fees Regulation of the European Research University for the academic year 2026/2027.

Part Two Fees

Article 2

1. An administrative fee of EUR 120 shall be charged for actions related to the admission procedure for studies commencing in the academic year 2026/2027. The fee must be paid no later than the application deadline.

2. No further fees shall be imposed within the meaning of Article 2 of the Fees and Tuition Fees Regulation of the European Research University.

The tuition fees for accredited study programmes commencing in the 2025/2026 academic year are as follows:

Part Four Payment of Fees and Tuition Fees

Article 4

1. The fee under Part Two is payable by bank transfer to the European Research University. (ERUNI) account number 2131120685/8040. The variable symbol is the applicant's or student's personal identification number, excluding the slash.
2. The tuition fees under Part Three are due no later than 15 days after the date of enrolment to studies for the first year of study and thereafter, no later than 30 June for the upcoming academic year. In the case of regular monthly tuition instalments, these are due no later than the 15th day of the calendar month preceding the month for which the tuition fee is paid.
3. The tuition fees under Part Three are payable by bank transfer to the ERUNI account number 2131120685/8040 and are non-refundable. The variable symbol is the applicant's or student's personal identification number. Further provisions regarding tuition fees and their payment are regulated by the study contract.
4. Tuition fees payments may be individually adjusted by the study contract or payment schedule.

Part Five Final Provisions

Article 5

This decree shall become effective on the date of its publication on the official notice board of ERUNI and shall take effect on the following day.
